

The European Commission 2019-2024 and older people

The European Commission is the European 'executive'. It is guardian of the EU treaties, proposes new legislation via its right to initiative, monitors the existing legislation and eventually can launch infringement procedures against breaches, and it implements the EU funds and programmes. In many areas, it has a strong impact on the concerns of older persons.

On 1 December 2019, a new European Commission under the leadership of the President Ms Ursula von der Leyen took office, with dedicated political guidelines.

Demographic change is shown as one of the priorities that her Commission wants to work on.

What are the main priorities of the 2019-2024 Commission relative to older people?

Ms von der Leyen was elected on a programme with the main accents put on the greening of the EU economy, developing EU actions in the area of defense and on the international scene and to take forward the UN Sustainable Development Goals. [In her political guidelines](#) and her address to the European Parliament as a candidate, Ms von der Leyen took the following commitments that are relevant to older persons:



- Make the **UN Sustainable Development Goals the compass for the European Semester** – the European Semester is the process to ensure member states to coordinate social and economic policies, including the fiscal prescriptions of the Stability and Growth Pact. Therefore, it has a strong impact on pension reforms and social protection systems
- Pursue social initiatives: implement the **European Pillar of Social Rights**, introduce a European Unemployment Reinsurance Scheme, a framework for minimum wage and an initiative on working conditions of platform workers. Implement existing initiatives, such as the Directive on Work-Life Balance for Parents and Carers
- Introduce a European plan to fight cancer
- Propose new **anti-discrimination legislation** and a **European Gender Strategy**
- Look into legislation regarding the ethical implications of artificial intelligence and propose a Digital Education Action Plan
- Explore **ways for EU actions to address demographic change** especially in rural areas and in the access to long-term care
- Create a **conference on the Future of Europe**




Which Commissioners are important regarding older citizens?



The European Commission president is the head of a college of 27 Commissioners, one coming from each member State. However, the college is collectively responsible towards the EU Parliament and Council and Commissioners are expected not to take instructions from or represent their member State, but the European interest




and the college as a whole. The Commissioners have divided their portfolios just like national ministers, with the addition that there are Vice-Presidents and Executive Vice-Presidents, who each lead a group of other Commissioners on a particular topic. The following Commissioners are most relevant to AGE's work.

This should propose actions to strengthen our approach at every key stage of the disease: prevention, diagnosis, treatment, life as a cancer survivor and palliative care.

How can older people's organisations work with the European Commission?

Any citizen can directly contact the cabinets of the European Commissioners with an issue that is relevant to the Commissioner's work. However, there are more structured and effective ways of making the voice of senior citizens known:

- The **structured consultations**: on each initiative that the European Commission is planning, a public consultation is conducted where citizens, NGOs, business organisations, trade unions, member states or others can voice their views and priorities in this area. Consultations run for a limited period of time and are available on a single website: <https://ec.europa.eu/info/consultations>
- **Taking part in Commission events**: the European Commission regularly organises events for European

and national stakeholders on issues that are relevant to running or upcoming initiatives. Regular events include seminars on the European Semester, the Annual Convention on Inclusive Growth etc. AGE aims to enable member organisations to participate in the most relevant events.

- Stakeholder organisations **can receive funding to work on EU issues**. This can be channelled through the Europe for Citizens programme (soon a strand in the Rights and Values programme) or the European Social Fund+; also through learning networks in adult education via Erasmus+. Also, senior citizens organisations can get involved as societal stakeholders in EU research projects promoted by universities and research centres using EU research funds.
